**Approval of the minutes of the 20 January 2015 meeting:** Approved without corrections.

**President Shelby Funk's Remarks**

- President Funk said that she did not have much to report other than that the Franklin College IT team was visiting to present the LANDesk system to the Senate and that someone from the Office of Online Learning would be visiting soon.

**Dean Dorsey's Remarks**

- Dean Dorsey reported that the process of asking departments to look into their documents regarding promotion and tenure is ongoing. Updated documents were due in the Dean's Office last Friday and will be reviewed. They plan to submit all updated documents to the Provost's Office for further review.
- Dean Dorsey also reported that the process of considering the new Experiential Learning Requirement continues. If approved, this requirement will be university-wide and will be applied to students matriculating in August, 2016. There has been an Ad Hoc Committee in the Franklin College to consider this requirement, and Linda Bachman has chaired a campus-wide committee. The Senate's Curriculum Committee is currently also reviewing this requirement.

**Committee Reports:**

- Academic Standards Committee: Received 2 petitions, approved 1, denied 1.
- Curriculum Committee: Approved 57 new courses, approved 121 course changes, and approved 3 proposals: microbiology major changes, ARHI 2121 approved for general

education core curriculum, and CHEM 1210/ 1210E approved for general education core curriculum. The committee is working on a draft proposal for the Experiential Learning requirement.

- Executive Committee: No new business reported.
- Committee on Faculty Affairs: No new business reported.
- Committee on Planning & Evaluation: The committee has been working on collecting data about the status of Lecturers and will submit a report soon.

**New Business:**

- Beth Woods, Jonathan Hardy, Tiffany Lindhardt, and Bryan McLucas of the Franklin College Office of Information Technology offered a presentation about the new LANDesk system. Many senators had questions about how the new system will affect faculty members' ability to download important software and how it will affect data collection from linked computer systems. The visitors answered senators' questions and invited faculty members to contact them with any further questions about the new system.
